Policy for determination of materiality for disclosure of events or information to the Stock Exchanges pursuant to regulation 30 (4) (ii) of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015

A. Purpose

This policy provides guidance to the Board, Key Managerial Personnel, Senior Management and staff on the assessment of materiality in financial matters, the independence of relationships and any other company matters that require appropriate disclosure to the Stock Exchanges.

B. Effective date of Policy

This Policy will be effective from 1st December 2015.

C. Policy

The Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations"), as amended from time to time under its Regulation 30(4)(ii) requires every listed entity to formulate a policy for determination of materiality of an event or information for the purpose of making disclosures to the stock exchange(s) and such policy is required to be disclosed on the Company's website.

The Board recognizes that materiality in case of certain events/information may be a matter of informed judgement. This Policy provides an overall governance framework for determination of materiality of events/information which require disclosure to the Stock Exchange(s) in accordance with the Listing Agreement.

D. Definitions

"Relevant Employees" shall include certain Functional Heads of the Company, the person who may be designated by the Functional heads and shall include employees of the Company who deal with or come into possession of potential material information/event in the course of the performance of his/her duties.

All other words and expressions used but not defined in this Policy, but defined in the SEBI Act, 1992, Companies Act, 2013, the Securities Contracts (Regulation) Act, 1956, the Depositories Act, 1996 and/or the rules and regulations made thereunder shall have the same meaning as respectively assigned to them in such Acts or rules or regulations or any statutory modification or re-enactment thereto, as the case may be.

E. Material Events or Information

In terms of Regulation 30 of the Listing Regulations, the events requiring disclosure by the Company, are provided as follows:

- (a) Events specified in Annexure I, forming part of this Policy are deemed to be material events and have to be disclosed to the Stock Exchanges without application of criteria for materiality as defined in Clause F of this Policy.
- (b) Events specified in Annexure II, forming part of this Policy shall be disclosed by the Company on application of criteria for materiality as defined in Clause F of this Policy.

This Policy shall also apply to the events which are not indicated in Annexure I or Annexure II but may have a material effect on the Company, or otherwise considered material in terms of the Listing Regulations read with this Policy.

F. criteria for Determining Materiality of Events or Information

Events/information shall be considered as material in nature as per Regulation 30(4) of the Listing Regulations if it meets one or more of the following criteria:

1. Qualitative Threshold:

- (a) The omission of an event or information, which is likely to result in significant market reaction if the said omission came to light at a later date; or
- (b) The omission of an event or information, which is likely to result in discontinuity or alteration of event or information already available publicly; or

2. Quantitative Threshold:

The omission of an event or information, whose value or the expected impact in terms of value, exceeds the lower of the following:

- (a) two percent of turnover, as per the last audited consolidated financial statements of the Company;
- (b) two percent of net worth, as per the last audited consolidated financial statements of the Company, except in case the arithmetic value of the net worth is negative;
- (c) five percent of the average of absolute value of profit or loss after tax, as per the last three audited consolidated financial statements of the Company.
- **3.** In case where the criteria specified hereinabove is not applicable, an event or information may be treated as being material if in the opinion of the Board of Directors of the Company, the event or information is considered material.

G. Mechanism to be adopted for Identifying and reporting potential material information/event by Relevant Employees.

- 1. During performance of one's role, the Relevant employee/(s) shall be responsible for identifying pertinent information/event as mentioned in Annexure I and Annexure II events which has potential to be classified as material information/event as per the policy.
- 2. Upon identification of potential material information/event, the Relevant Employee shall promptly report the details of such potential material information/event to the Authorized Officer(s).
- 3. Any other event, even if not covered under the Listing Regulations but is potentially of price sensitive nature, must also be informed for further evaluation, to the Authorized Officers. After evaluation, the Authorized Officers shall if required issue a suitable disclosure to the Stock Exchanges.

H. Mode of Communication.

The aforesaid details can be submitted to the Authorized Officer(s) by the Relevant Employee using written communication methods such as emails, internal memos, or any other appropriate official means.

The details so submitted shall be authentic and comprehensive to enable the Authorised Officers to make informed decision/take appropriate actions. The Relevant Employees should exercise necessary diligence to ensure confidentiality of the details being submitted/so submitted to the Authorised Officer(s).

The Relevant Employees may approach the Authorised Officer(s) for seeking guidance/clarity to ensure effective implementation of this policy.

The Company Secretary of the Company may conduct periodic trainings/sensitization programmes and/or release FAQs, SOP, framework to further assist relevant employees for effective implementation of this policy.

I. Disclosures specified by the Board of Directors

Without prejudice to the generality of the preceding clauses, the Company may make disclosures of events/information as specified by the Board of Directors from time to time.

J. Timing of disclosures

The Company shall first disclose to the stock exchange(s) all events or information which are material in terms of the provisions of the Listing Regulations as soon as reasonably possible and in any case not later than the following:

- (i) thirty minutes from the closure of the meeting of the Board of Directors in which the decision pertaining to the event or information has been taken;
- (ii) twelve hours from the occurrence of the event or information, in case the event or information is emanating from within the Company;

(iii) twenty-four hours from the occurrence of the event or information in case the event or information is not emanating from within the Company.

Further, disclosure with respect to events for which timelines have been specified in the Listing Regulations and circulars issued thereunder, shall be made within such timelines as prescribed by SEBI.

The format of disclosure shall be as prescribed by SEBI under Listing Regulations and / or and circulars issued thereunder, from time to time.

K. Authorized Officers to determine materiality/make disclosures

The Managing Director, Chief Financial Officer and the Company secretary shall be the Authorised Officers and will be jointly or severally responsible for determining materiality of the information in line with the extant Regulations and this Policy. The Managing Director, Chief Financial Officer and the Company Secretary will also be severally responsible for disclosing to the said Material Information/Event to the Stock Exchanges.

L. Disclosure on website

The Company shall disclose on its website all such events or information which have been disclosed to Stock Exchanges pursuant to this Policy, and such disclosures shall be hosted on the website of the Company for a minimum period of five years and thereafter as per archival policy of the Company, as disclosed on its website.

M. Updating Material developments

The Company shall, with respect to disclosures referred to in this Policy, make disclosures updating material developments on a regular basis, till such time the event is resolved/closed, with relevant explanations.

N. Replies to queries of Stock Exchanges

The Company shall provide specific and adequate reply to all queries raised by the Stock Exchange(s) with respect to any events or information.

O. Review

The Policy is subject to review by the Board from time to time. In case of any amendment(s), clarification(s), circular(s), etc. issued by the relevant authorities, not being consistent with the provisions laid down under this Policy (including but not limited to the materiality threshold set out in paragraph F, Annexure I and Annexure II as may be applicable) then, subject to approval of the Board, this Policy may be amended to give effect to such amendment(s), clarification(s), circular(s), etc.

SCHEDULE III

The following shall be events/information, upon occurrence of which listed entity shall make disclosure to stock exchange(s):

A. Events which shall be disclosed <u>without any</u> application of the guidelines for materiality as specified in sub-regulation (4) of regulation (30):

Explanation (1) - For the purpose of this sub-paragraph, the word 'acquisition' shall mean-

- (i) acquiring control, whether directly or indirectly; or
- (ii) acquiring or agreement to acquire shares or voting rights in a company, whether existing or to be incorporated, whether directly or indirectly, such that
 - (a) the listed entity holds shares or voting rights aggregating to five per cent or more of the shares or voting rights in the said company; or
 - (b)there has been a change in holding from the last disclosure made under sub-clause (a) of clause (ii) of the Explanation to this sub-paragraph and such change exceeds two per cent of the total shareholding or voting rights in the said company; or
 - (c) the cost of acquisition or the price at which the shares are acquired exceeds the threshold specified in sub-clause (c) of clause (i) of sub-regulation (4) of regulation 30.

Explanation (2) - For the purpose of this sub-paragraph, "sale or disposal of subsidiary" and "sale of stake in associate company" shall include-

Explanation (3)- For the purpose of this sub-paragraph, "undertaking" and "substantially the whole of the undertaking" shall have the same meaning as given under section 180 of the Companies Act, 2013.]

- 2. Issuance or forfeiture of securities, split or consolidation of shares, buyback of securities, any restriction on transferability of securities or alteration in terms or structure of existing securities including forfeiture, reissue of forfeited securities, alteration of calls, redemption of securities etc.
- 3. 410[New Rating(s) or] Revision in Rating(s).
- 4. Outcome of Meetings of the board of directors: The listed entity shall disclose to the Exchange(s), within 30 minutes of the closure of the meeting, held to consider the following:
 - a) dividends and/or cash bonuses recommended or declared or the decision to pass any dividend and the date on which dividend shall be paid/dispatched;
 - b) any cancellation of dividend with reasons thereof;
 - c) the decision on buyback of securities;
 - d) the decision with respect to fund raising proposed to be undertaken
 - e) increase in capital by issue of bonus shares through capitalization including the date on which such bonus shares shall be credited/dispatched;
 - f) reissue of forfeited shares or securities, or the issue of shares or securities held in reserve for future issue or the creation in any form or manner of new shares or securities or any other rights, privileges or benefits to subscribe to;
 - g) short particulars of any other alterations of capital, including calls;
 - h) financial results;
 - i) decision on voluntary delisting by the listed entity from stock exchange(s):

 411[Provided that in case of board meetings being held for more than one day, the financial results shall be disclosed within thirty minutes of end of the meeting for the day on which it has been considered.]
- 5. Agreements (viz. shareholder agreement(s), joint venture agreement(s), family settlement agreement(s) (to the extent that it impacts management and control of the listed entity), agreement(s)/treaty(ies)/contract(s) with media companies) which are binding and not in normal course of business, revision(s) or amendment(s) and termination(s) thereof.

or control of the listed entity or impose any restriction or create any liability upon the listed entity, shall be disclosed to the Stock Exchanges, including disclosure of any rescission, amendment or alteration of such agreements thereto, whether or not the listed entity is a party to such agreements:

Provided that such agreements entered into by a listed entity in the normal course of business shall not be required to be disclosed unless they, either directly or indirectly or potentially or whose purpose and effect is to, impact the management or control of the listed entity or they are required to be disclosed in terms of any other provisions of these regulations.

Explanation: For the purpose of this clause, the term "directly or indirectly" includes agreements creating obligation on the parties to such agreements to ensure that listed entity shall or shall not act in a particular manner.]

6. ⁴¹³[Fraud or defaults by a listed entity, its promoter, director, key managerial personnel, senior management or subsidiary or arrest of key managerial personnel, senior management, promoter or director of the listed entity, whether occurred within India or abroad:

For the purpose of this sub-paragraph:

- (i) 'Fraud' shall include fraud as defined under Regulation 2(1)(c) of Securities and Exchange Board of India (Prohibition of Fraudulent and Unfair Trade Practices relating to Securities Market) Regulations, 2003.
- (ii) 'Default' shall mean non-payment of the interest or principal amount in full on the date when the debt has become due and payable.

Explanation 1- In case of revolving facilities like cash credit, an entity would be considered to be in 'default' if the outstanding balance remains continuously in excess of the sanctioned limit or drawing power, whichever is lower, for more than thirty days.

Explanation 2- Default by a promoter, director, key managerial personnel, senior management, subsidiary shall mean default which has or may have an impact on the listed entity.]

- 7. Change in directors, key managerial personnel (Managing Director, Chief Executive Officer, Chief Financial Officer, Company Secretary etc.), 414[senior management,] Auditor and Compliance Officer.

- i. 417[The letter of resignation along with] detailed reasons for the resignation 418[***] as given by the said director 419[***].

- ii. The independent director shall, along with the detailed reasons, also provide a confirmation that there is no other material reasons other than those provided.

- 21. Voluntary revision of financial statements or the report of the board of directors of the listed entity under section 131 of the Companies Act, 2013.]

B. Events which shall be disclosed upon application of the guidelines for materiality referred sub-regulation (4) of regulation (30):

- 1. Commencement or any postponement in the date of commencement of commercial production or commercial operations of any unit/division.
- 2. ⁴³⁴[Any of the following events pertaining to the listed entity:
 - (a) arrangements for strategic, technical, manufacturing, or marketing tieup; or
 - (b) adoption of new line(s) of business; or
 - (c) closure of operation of any unit, division or subsidiary (in entirety or in piecemeal).]
